

Consolidated Mining Standards Initiative

In November 2025, Global Delta Capital signed a joint investor letter to the Consolidated Mining Standards Initiative (CMSI) in response to its final public consultation. CMSI is a multi-stakeholder effort to consolidate and strengthen global mining standards, promoting consistent, responsible practices across environmental, human rights, labour, governance, and community impact issues.

Representing over USD 750 billion in assets, the investors urged CMSI to enhance its approach to governance, transparency, tailings management, assurance, labor rights, Indigenous rights (FPIC), community engagement, and human rights due diligence to reduce investor risk and improve accountability within the mining sector.
